3 3. I joined this suit at its inception after attending several Town Council meetings on 4 water rates and speaking to John Lockton about my concerns with their legality. I opted to join in 5 this lawsuit when it became apparent that our political efforts to get the Town to acknowledge the 6 issues with its water rates was not working. In fact, I was involved in the litigation even before it 7 was filed, in assisting John Lockton with getting counsel up to speed on the various issues with the 8 Town's rates.

9 4. During the years that this lawsuit has been pending, I have continued to remain
10 closely involved with it. To that end, I have reviewed the Town's water rate and drought records
11 to assist counsel in understanding them, I have reviewed all of plaintiffs' filings in the case as well
12 as those of the Town, I have met with friends, neighbors, and members of the community to
13 discuss the lawsuit and answer questions, I have attended court hearings, a settlement conference,
14 and mediation, and I have been involved in the settlement discussions thereafter. Over the years, I
15 estimate that I have dedicated over 80 hours of my own time in pursuit of this case.

6. During the course of this lawsuit, I have received extensive condemnation from
some very vocal members in our community who did not support our cause. A newspaper article
was written on our case in the San Jose Mercury News and it was a photo of my house (and name)
that were featured in the article. This meant that much of the feedback (good and bad) from the
article was directed towards me. While this pressure of the course of many years caused me a
significant amount of stress, it did not deter me in my efforts to seek the best result possible for the
class.
